- On April 2<sup>nd</sup>, approached by Board Member to help deal with COVID and clinical education

## CETF Decided 4/8/20 on Webinar Conversations



- CETF responded to Ceserina Thompson and Teri Stumbo who approached Staff and Board; webinars were feasible via RingCentral
- The team was created:

  - John Colbert, Jacoby Lawrence and Kristen Truong, ASAHP headquarters
  - Multiple members of CETF
- After successful pilot April 17, four additional webinars were conducted by end of June



- Fortunately, Marcie Weinstein, CETF member, and Kristen Truong, ASAHP staff, had worked all year to create the CETF website
- ASAHP staff advertise programs, conduct preview training sessions, manage the webinars and logistics of registration, conduct post-session surveys, and aggregate outcomes
- CETF members select topics with some Board guidance, moderate events, present and invite external speakers, participate in preview sessions and webinars, and discuss outcomes




- Scheduled events Fridays 12:00 to 2:00 ET to accommodate both coasts

- Participants post real-time comments or questions in Q&A section








